

**AMENDMENT TO [Memorandum of Understanding] of (21.05.2020); Filing No:

(hereinafter referred to as "**TI Korea**").

AMENDMENT No1

The Parties hereby agree to the following amendment(s):

In the preamble, paragraph one, sentence one, the words "**in Busan, the Republic of Korea**" shall be replaced by "**originally planned for Busan, the Republic of Korea, to be held virtually, connected to a conference studio in Korea.**"

In Article 1, sentence 2, the words "**which will take place from Tuesday 01 to Friday 04, December of 2020, in Busan, Korea**" shall be replaced by "**which will take place from Tuesday, 01 to Friday 04, December of 2020 (Monday, 30 of November to Saturday, 05 of December with pre- and post-Conference sessions) virtually. The virtual holding of the Conference was decided due to the effects of the COVID-19 pandemic.**"

In Article 2, following, sentence 2, the sentence "**Any unused Core Funds, which may not be spent due to the virtual holding of the Conference, shall be returned to the Korean government.**" shall be inserted.

In Article 2, sentence 4, the words "**In case where, expenses for holding the conference exceeds the Core Fund provided by the Republic of Korea due to a larger number of participants than expected or other unexpected costs, proceeds from registration fees shall be used to cover these excess costs.**" shall not be applicable.

In Article 2, sentence 5, the words "**Renting the Conference venue**" shall be replaced by "**Hiring a virtual conference platform, connected to a conference studio in Korea**".

In Article 2, sentence 7, "**The parties to this MoU also commit to do efforts in order to raise additional funds** for the Conference "**Participation Fund**" (PF) to support VIP and expert participation as well as broad international attendance, especially from developing countries." shall not be applicable.

Article 9 shall be replaced by the following: "The ACRC and the IACC Team at TI-S shall jointly hire a professional **Virtual Conferences Platform Company (VCPC)** to manage and stream the 19th IACC as well as to manage all aspects related to participants registration and use of the virtual platform. ACRC shall also hire a Conference Organizing Company (COC) to provide set-up of a local conference studio and its operation, professional translation services, local promotion, and any other service that the VCPC cannot provide. The **VCPC and COC's** responsibilities and the Virtual Conference Platform Terms of Reference shall be detailed in the 19th IACC Implementation Plan to be prepared in accordance with paragraph 13 below."

Article 10 shall be replaced by the following: "**Venue, date and target attendance.** The 19th IACC shall take place from 01 to Friday 04, December of 2020 (Monday, 30 of November to Saturday, 05 of December with pre- and post-Conference sessions). It shall start with an opening ceremony and shall end on the fourth day with a closing plenary. The Conference shall offer virtual plenary sessions for up to 3,000 participants, up to eight virtual parallel workshop sections with a virtual attendance of up to 500 participants, as well as provide virtual spaces for press conferences, young journalists hub, the IACC Film Festival, the Fair Play Music Competition Festival, side events and hoc meetings as specified in the Implementation Plan."

Article 12, sentence 2, the words "With the new date and venue agreed among parties" shall be replaced by "With the dates and Virtual Conference platform agreed among the parties."

All other terms and conditions of the MoU shall remain unchanged.

The above mentioned changes shall enter into force upon signature by all Parties.


